

Indiana Outreach programs supporting EHDI in Indiana

- SKI HI Early Intervention program: Family Centered relationship based educational program, empowers families to find the communication and language that works for the child
- FLIP and LEAP programs, offer family support through play groups with both languages
- Lending library
- Deaf Role Model program
- Audiology Services

Collaborative Projects with Wisconsin's EDHI Program

- Wisconsin's Parent Summit (2003) setting goals for future programming
- Parent Notebook (used for GBYS)
- Initial implementation of the GBYS program & Follow Through program
- Initial implementation of the Annual Statewide Family Conference
- WE-TRAC Data & Tracking system (referrals to Outreach)

Collaborative projects with Indiana's EHDI program

- Family Resource Guide
- Family Conference for start up in 2004 collaborated with DOH, brought Hands & Voices to Indiana, each year more ownership by Hands & Voices
- Developed Eligibility Determination Team with Part C
- Investing in Family Support committee
- Physician Tool Kit
- Parent Tool Kit (2007)
- Eligibility Determination Team: OPCOM

Wisconsin Outreach & Systemic Change

- Birth to 6 Redesign Summit
- ARRA funding: Western Region Birth to 6 Redesign pilot (Regional Services Coordinator and development of a regional "team")
- Efforts of DPI / DHS towards a comprehensive B-6 (instead of B-3 and 3-6) focus
 - ARRA funding to support Birth to 3 Services for school age children?
 - Involvement with subcommittee, focusing on Sensory
 Disabilities, of Interagency Coordinating Council (oversees
 Birth to 3) and development of eligibility, best practices,
 competencies)
 - WDBTAP interface with Birth to 3 for Deafblind students, including coaching and professional trainings

Indiana Systemic changes

- UNHS protocols, Audiology protocols, DAE forms
- Part C protocols
- Regional audiologists
- Part C program, First Steps: training for service coordinators and providers, technical assistance to Part C, eligibility determination procedures
- Participation on LPCC committees
- Participation on EHDI Advisory Committee

The Challenges....

- WI: Information sharing between 3 agencies (Outreach, Wisconsin Birth to 3 and Wisconsin Sound Beginnings) and interface of 2 different state agencies (Dept. of Public Instruction and Dept. of Health Services)
- IN: Interface of 3 state agencies and partnership roles, perception of ISD, collaboration and role changes with new organizations and programs emerging due to EHDI

The benefits....

- Despite challenges, there are many good things to be accomplished in collaboration. The work of Outreach can support the effort of EHDI.
 - Sustainability of funding
 - Expanded funding / grant opportunities
 - Value of having a variety/the diversity of perspectives (medical and cultural) regarding what it means to be deaf/hard of hearing – parents and providers need the WHOLE picture.
 - Coordinated, cohesive statewide approach to serving our youngest children with integrated programming from detection to intervention, from birth to adulthood!
